The Family Economic Mobility Program Planning Tool helps Head Start parent leaders and staff assess their program's family economic mobility strategy and professional development needs. Teams may use this tool at any time during the five-year program project period to review the following:

- Program's current efforts and prioritize opportunities to partner with families
- Program goals and activities with families related to economic mobility
- Opportunities to use existing data about family economic mobility to inform staff training, professional development, and family services
- Common goals that families in your program set for themselves and their children
- Capacity of staff and community partners to support families in reaching their goals
- Areas for additional learning about economic mobility

Planning Family Economic Mobility Strategy in Five Steps

Follow these five steps to plan your program's family economic mobility strategy:

- 1. Review Program Economic Mobility Goals
- 2. Learn About the Economic Mobility Goals of Families
- 3. Review What You Learned
- 4. Decide Your Approach
- 5. Reflect and Plan

Each step includes a series of questions. Use the downloadable worksheet to record your responses. Every program and setting is different, so apply this tool to your specific needs.

Remember your BROAD goals for the five-year program cycle as you work on the tool. The BROAD acronym stands for:

- Beyond current expectations
- Responsive
- Organization-wide
- Aspirational
- Dynamic

- Refer families to a community organization or service provider
- Partner with an organization, business, bank or credit union, educational institution, or service provider to jointly provide a service
- Do it yourself and directly provide a service as part of your Head Start program.
